- 3. Current Legislative Initiatives: Superintendent Cassidy shared information on recent legislative action.

Superintendent Cassidy had the pleasure of meeting with Ottawa Area Superintendents and West Michigan legislators. Chris Glass from Education Advocates of West Michigan presented on Legislative priorities for the 23-24 session.

Continue Implementation of a student-centered funding formula as outlined by the School Finance Research Collaborative.

It has become more widely accepted that a student-centered formula is necessary to ensure schools receive the necessary resources to provide each student with the individualized support and resources they need to succeed. When each student has the necessary support, they can fulfill their full potential.

Education Advocates presented the following need to be done:

- Increasing foundation grant to \$10,421
- Fully funding special education
- Additional 35% funding for at-risk students
- Increased support for English learner students
- Provide categorical support for transportation
- Provide additional support for Career Technical Education

Discussion regarding the importance of student-centered funding without restrictive categoricals.

Other asks:

- Streamline teacher and administrator evaluation
- Amend the "Read by Grade 3" law
- Transition to a single school accountability system
- Provide flexibility in the Michigan Merit Curriculum (Alg. II)
- Expand Opportunities for Career Technical Education and work-study
- Continue efforts to develop educator work force.
- 4. Strategic Plan Update: Superintendent Cassidy provided a strategic plan update.
- 5. Recommendation to amend Superintendent Cassidy's contract language.

Moved by Lois Mulder, supported by Linda Falstad, that the Board of Education amend Superintendent Cassidy's contract language under Section 7, Base Compensation for annual increase to include "not to exceed 2%" so it reads:

For each succeeding fiscal year of this Agreement (July 1 through June 30), the annual base salary will increase by a minimum of the average % increase to salary received by tenured teachers with the Holland City School District for such related fiscal term, <u>not to exceed 2%.</u>
