#### Legislative Updates:

Is there a weighted formula for:

- poverty? -English Learners? -SWD? -career and tech education?
- Does the state provide funding for transportation?
- Is there a dedicated funding amount per child for GSRP?
- Does it match the School Finance Research Collaborative (SFRC) Recommendation?
- In spite of the two best back-to-back funding years in state history since Proposal A, education remains underfunded in this state.
- Based on the SFRC recommendations and depending on the result of the capital cost study and the transportation study, Michigan schools continue to be underfunded by \$2 billion (low) to \$6 billion (high) annually.

#### The Education Trust-Midwest:

Michigan's Foundation Allowance is currently sixth in the nation, while our additional funding weights are near the bottom across the board.

#### In FY24, Holland will receive:

A total of \$14.5 million through the Opportunity Index - an increase of more than \$2.5 million over last year. Upon full implementation, Holland will receive \$44.5 million annually through the Opportunity Index.

An estimated additional \$278 thousand for English Learners which is a 50 percent increase.

An estimated additional \$354 thousand for students with disabilities.
