- 1. Makin vs. Carson- Private Schools

- The issue at hand in Makin v. Carson was Maine providing tuition support to secular private schools, but not religious private schools.
- The Supreme Court ruled the state could not discriminate if it provided financial support to private schools.
- This does not impact Michigan as we have a constitutional prohibition against funds going to all private schools secular and religious.

Kennedy vs. Bremerton- Prayer

- Supreme Court ruled that schools cannot bar their employees from conducting "private" and "personal" religious expression on the job.
- Private implies that students were not required or forced to join in the prayer or religious expression.

• Public prayer or religious expression is still prohibited in schools.

Legislative Session Calendar

- The legislature is expected to have a very limited session calendar throughout the fall.
- The last session day was June 30th and they're expected to meet once in September and October.

Let MI Kids Learn- Signatures Filed

- Let MI Kids Learn is expected to submit 500,000 signatures for its initiative.
- Once signatures are verified and its determined they met the minimum threshold, the legislature has 40 days to take action.
 - o Vote to support or put forward an alternative proposal for the ballot.
- The initiative has spent over \$10 million to collect signatures.

Working Post Retirement

- On July 20th Governor Whitmer signed House Bill 4375 making it Public Act 184 of 2022.
- ORS has put together <u>general information</u> and a <u>helpful FAQ</u> to guide districts, employees and retirees through the law change.
- In simple terms the new law means:
 - o Retirees who were not already employed, will need to wait 9 months to become employed.
 - o Employed or previously employed retirees have full flexibility to return to work in any capacity, for any duration and compensation.
- Retirees after 30 days are able to volunteer and be in contact with their district, they just can't be employed for 9 months.

Substitute Teacher Flexibility- NO MORE

- Flexibility provided by Public Act 149 of 2021 expired on June 30, 2022.
- Last year districts had flexibility to place school employees as substitute teachers as long as they had a high school diploma.
- Given the continued shortage we are working to extend flexibility into next school year.

Total Funding Allocations for FY 22-23

- \$25 million-MI Future Educator Fellowship Program
- \$175 million- Grow Your Own Programs
 - o Grants to districts and ISDs to provide a no-cost pathway for employees to become certified teachers.
 - Up to 10% of a district's or ISD's funds may be used to implement a program to encourage students in grades 6-12 to consider a career in education
 - Requires a recipient to work as a teacher in the district or ISD for the same number of years funding was received.
- \$50 million- MI Future Educator Student Teacher Stipend Program
- \$15 million- Troops to teachers
- MICHIGAN FUTURE EDUCATOR FELLOWSHIP
 - \$305 million to offset tuition costs for college students earning their initial teacher certification
 - \$25 million is for this fiscal year and the other \$280 million is in a reserve fund for MI Future Educator Fellowship grants.
