- 2. National Principals Month: Superintendent Cassidy announced October is National Principals Month and thanked our principals for their dedication.

Governor Whitmer has signed <u>HB 4752</u>, legislation that allows retired educators with a bona fide separation to return to work in a school with some limitations after just a 30 day sit out. The bill was given immediate effect by the Michigan Legislature, so it is now law. The bill applies to all current and future retirees, even those who recently retired and have so far been unable to return to work in a school due to the nine month sit out previously in law. That means schools can immediately begin working with these recent retirees either directly or through a third party contractor as long as certain conditions are met.

Here are the details schools need to know with regard to the new law:

- During their first six months of retirement, recent retirees may not earn more than \$15,100 per calendar year.
- Retirees who were working in any position other than superintendent at the time of their

retirement may be hired to fill any position.

- Retirees who were working as superintendents at the time of their retirement may work in any position except superintendent.
- After sitting out for six months (instead of the nine months in current law), all retirees may return to work in any position with no earnings limits. Any time they spent working under the \$15,100 per year income cap counts toward the six month sit out period.
- The new law has a five year sunset, so the Legislature will eventually need to take additional action, but not for some time.
- After the sunset, the law reverts to a nine month sit out and no earnings cap exception

Legislation to revise teacher and administrator evaluations was on the docket in the Senate Committee on Education this week. Points of discussion centered around:

- Collective bargaining and grievances as part of the evaluation process
- student growth
- Changing effectiveness ratings from 4 to 3
- Observation requirements
- probationary periods

### OK Conference Update

Sparta, Coopersville, Allendale, Cedar Springs, Greenville, Lowell, Kenowa Hills are seceding from the OK Conference.

All of these schools gained approval from their boards of education and they have submitted letters to the OK Conference.

All OK conference schools are asked to vote on allowing these schools to break away from the conference (Ballots due on Monday)

- 36 need to vote yes for the proposal to pass in accordance with the bylaws.
- All schools we have heard from are voting "NO"
- It has been said that the schools are leaving regardless of the results.

## Background

Realignment was passed on May 8 by a vote 42-6. 4 of these 7 schools voted yes on that realignment.

The first conversations around a possible secession this summer.

According to feedback we have received, this process has not followed the bylaws.

## Timeline moving forward:

- the proposal will fail and we will be notified on Monday at 12:30pm
- The schools will have 1 week to notify the conference if they are leaving anyway.
- Realignment committee will meet on Oct. 31st or Nov. 1st with a new proposal for realignment.
