- 2. 86th Veterans Day Observance: Superintendent Cassidy recognized our past and current serving members of the military and thanked Holland High School Administration for their 86th Veterans Day Observance held on November 10, 2023.

SB 396 + Sub SB 395 – Polehanki + McDonald Rivet: The legislation makes changes to how teachers and school administrators are evaluated, specifically as it relates to student academic progress.

House adopted a substitute that would require student academic progress to fully account for 20 percent of an evaluation. Which scores are used and how heavy they would weigh in an evaluation would be part of locally bargained negotiations

The new system will reduce the percentage of a teacher's score based on student growth or learning objectives to 20% from the current 40% without requiring state testing data be used. How and what goals are measured will be locally bargained.

Other provisions reduce ratings categories from four to three: effective, developing and needs support; require observations for at least 15 minutes with timely written feedback; and allow effective teachers to be evaluated triannually or biannually (subject to bargaining).

Bullying/Harassment

The Board will vigorously enforce its prohibition against discriminatory harassment based on race, color, national origin, sex (including sexual orientation and gender identity), disability, age (except as authorized by law), religion, height, weight, marital or family status, military status, ancestry, or genetic information (collectively, "Protected Classes") that are protected by Federal civil rights laws (hereinafter referred to as unlawful harassment), and encourages those within the School District community as well as Third Parties, who feel aggrieved to seek assistance to rectify such problems. *The Board will investigate all allegations of unlawful harassment and in those cases where unlawful harassment is substantiated, the Board will take immediate steps to end the harassment, prevent its recurrence, and remedy its effects. Individuals who are found to have engaged in unlawful harassment will be subject to appropriate disciplinary action.*

Other Violations of the Anti-Harassment Policy

The Board will also take immediate steps to impose disciplinary action on individuals engaging in any of the following prohibited acts:

- A. Retaliating against a person who has made a report or filed a complaint alleging unlawful harassment, or who has participated as a witness in a harassment investigation.
- B. Filing a malicious or knowingly false report or complaint of unlawful harassment.

- C. Disregarding, failing to investigate adequately, or delaying investigation of allegations of unlawful harassment, when responsibility for reporting and/or investigating harassment charges comprises part of one's supervisory duties.
- **X. CONSIDERATION OF PETITION FOR REINSTATEMENT:** Superintendent Cassidy brought forward the recommendation of the Hearing Committee to reinstate student 1113230800, with conditions.

Moved by Lois Mulder, supported by Linda Falstad, that the Board of Education approve the recommendation to reinstate Student 1113230800, with conditions as presented. The motion was unanimously approved.
