Retirees Return to Work

- High-level: Discussions are underway with organizations to amend the law governing working post-retirement.
- Senate Bill 726 could be used as a vehicle bill to reduce the sit out period for this year only from 9 to 6 months.
- If passed, this would allow employees who retired at the end of June to be rehired after January 1.

<u>Substitute Flexibility</u>

- High-level: Legislative interest in extending the substitute teacher flexibility.
- House Bill 6411 reinstates the substitute teacher flexibility that expired June 30, 2022. This bill extends the flexibility until June 30, 2024.
- Allows districts to place any employee as a substitute teacher as long as they have a high school diploma.
- The policy change from the last time around was the individual must be permitted.
- **XIII. OTHER:** No other items where discussed.
