- 2. Current Legislative Initiatives: Superintendent Cassidy shared information on recent legislative action.
 - HB 4188, which amends the Public School Employees Retirement Act to require the retirement system to offer access to one or more fixed annuity options and to allow the system to offer access to one or more variable annuity options provided by a selected annuity provider.
 - This bill requires the investment board to select two or more annuity providers based on a competitive proposal process and to contract with a provider that meets certain conditions.
 - HB 6042, which allows school boards to submit electronic "critical mapping data" to local law enforcement to better assist them in responding to active shooter situations.
 - MDE released a memo yesterday that states that any district or ISD that offers learning under section 21f (or a school of excellence that is a cyber school as defined in section 551) is required to submit a report to MDE that reports the per-pupil costs of operating the virtual learning by vendor type and virtual learning model.
